Old Business: Upcoming changes to the FSMS Constitution were discussed.

The majority of Chapter members present were against changing Article II (Section 8) of the constitution in regards to requiring Fellow Member status for 5 years before being eligible for election to Life Member status.

The majority of Chapter members present were in favor of allowing delinquent members to be reinstated by paying only the dues for the current year. The Constitution currently requires payment for the delinquent year also.

The upcoming convention was discussed. Oscar Pittman made a motion that any Chapter Officers that chose to attend the conference receive \$300 from the Chapter to help defray their expenses. Motion was seconded by Bill Butler and passed unanimously.

David Glaze made a motion that Ron Milstid attend the conference as a past-President and also receive \$300 from the Chapter to help defray his expenses. Motion was seconded by Mike Blanton and passed unanimously.

Committee Reports: David Glaze reported that the Panhandle Chapter Golf Tournament on May 15, 2010, at Cypress Lakes (Solutia) was a success. Bill Butler's team came in first. Net profits were \$1909.86.

David Glaze made a motion for the Chapter to donate \$750 to the PAC fund and \$750 to the Scholarship fund. Motion was seconded by Oscar Pittman and passed unanimously.

David Glaze suggested that due to the economy, the Chapter annual picnic be cancelled. The membership agreed.

New Business:
